**RESOLUTION CREATING “ELM AVENUE FLOOD ELIMINATION PROJECT FUND” AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Norwood having been successful in receiving grant funding for the Elm Avenue Flood Elimination Project; and

**WHEREAS**, Ohio law requires that political subdivisions receiving funds pass resolutions designating grant funding received for special purposes, be for the purposes of designating funds received, to be expended for the special purposes authorized by the grants; now therefore,

**BE IT RESOLVED**, by the Council of the City of Norwood, Hamilton County, Ohio that:

**SECTION 1.** There is created a special revenue fund for the City of Norwood to be known as the “**FUND 3098 - ELM AVENUE FLOOD ELIMINATION PROJECT FUND**”. The purpose of this fund is to pay construction management fees and other associated costs for the stormwater and water detention project known as Elm Avenue Flood Elimination Project..

**SECTION 2.** This Resolution is hereby declared to be an emergency Resolution and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to create the special revenue fund immediately, so grant funds received can be deposited, as soon as those funds become available, and funds can be disbursed for the purpose stated this resolution.
